### **CCBI comments on the possible draft text for paras 10, 11 and 29 of the Operational Document**

#### **Operational part of the final document / Tunis Agenda for Action / Tunis Plan of implementation**

**Paragraph 11** – CCBI urges that we assure the sustainability of progress towards the outcomes of WSIS, not the sustainability of the process.

**Paragraph 11c** – Should be deleted. Implementation is not an appropriate time for further debate.  
"Review" is already covered in 11b under "evaluation".

**Paragraph 12d** – It is unclear who undertakes this and what happens to the report. CCBI suggests that assessments of this kind are best done by multiple agencies with multistakeholder involvement.

**Paragraph 13a** – “could carry out WSIS implementation activities” is unclear. CCBI recommends replacing it with “...could evaluate information society development ....”  
In addition CCBI recommends replacing “organizing policy debate” with “facilitate policy debate”.

**Paragraph 14b** – Instead of "Each UN agency", CCBI suggests using the “stakeholder groups”.

**Paragraph 14c** – Instead of "coordination of multistakeholder activities", CCBI suggests "awareness of multistakeholder activities".

**Paragraph 14d** – the bracket [, such as the ITU-led initiative "Connect the World"] should be deleted. There are other (existing or upcoming) examples of partnerships, and mentioning one specific example might lead to lengthy and fruitless discussions on the importance of individual projects.

**Paragraph 14e** – CCBI recommends the following edited version of paragraph 14e: “The modalities of coordination of implementation activities among the UN agencies should be defined by the UN Secretary General on the basis of existing practices within the UN system [and within the WSIS], using the experience of, and the activities undertaken by, UN agencies in the WSIS process – notably ITU, UNESCO and UNDP”.

#### **Chapter Four: The way ahead**

In general, these paragraphs are fairly redundant with Chapter 1 and CCBI suggests that they could be integrated in Chapter 1.

**Paragraph 29** – This paragraph is vague. Policies are sometimes appropriately determined by other stakeholders. This paragraph is especially redundant with paragraph 34 in the same chapter.

The World Summit on the Information Society (WSIS) was held during the week of 8 December 2003 in Geneva, culminating in the Summit segment on 10-12 December 2003. The second part of this Summit will take place in 2005 in Tunisia.
