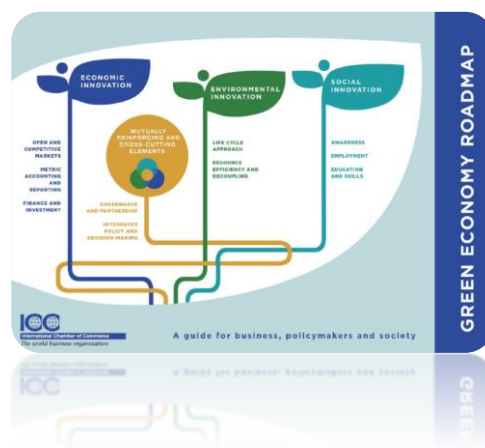
## ICC GREEN ECONOMY ROADMAP

**A guide for business, policy makers and society to assist in the development and implementation of policies and actions towards a green economy**

The [ICC Green Economy Roadmap](#) represents a comprehensive and multidisciplinary effort to clarify and frame the concept of “green economy” and promote a more common understanding of it. The Roadmap highlights the essential role of business in bringing solutions to common global challenges and calls for innovation, collaboration and governance on ten key conditions to be worked on simultaneously, both bottom up and top down, as well as in the short and long term. These conditions recognize the interdependence of the economic, social and environmental dimensions of sustainable development and seek to integrate them in a more holistic manner both in terms of business strategies and enabling policy mixes for the transition towards a “green economy”.

The Roadmap is a forward-looking document meant to serve as a means of reference for current and future actions. It is available in both online and print form.

ICC will also launch an online platform that represents over 70 examples of best practices as well as proposals for collaboration. It is meant to provide information and evidence of how mainstreaming sustainability can work in practice in many diverse situations for a green economy. This knowledge hub will allow users to search for and download best practices on specific topics or countries and regions.
