## IRAN and ICC Arbitration

Iranian companies and entities, both private and state, have been involved in ICC arbitrations as both claimants and respondents.

Statistics indicate an increase in the use of ICC arbitration services by Iranian companies and commercial entities. An ICC arbitration clause is frequently incorporated in commercial and investment contracts that are concluded with non-Iranian companies. ICC arbitration is becoming the primary tool used for resolving commercial disputes.

This seminar will provide practical information on the use of ICC arbitration services for the settlement of international disputes. Experienced practitioners of ICC arbitration including the Chairman of the ICC International Court of Arbitration will deliver speeches on practical and theoretical aspects of ICC arbitration, with due regard to Iranian Law requirements, in particular the Law in International Commercial Arbitration LICA.

This one-day seminar is organized with the coordination of the ICC International Court of Arbitration and the Iranian National Committee of the ICC. For the first time, Professor Pierre Tercier, the Chairman of the ICC International Court of Arbitration, and Mr. Serge Lazareff, the Chairman of the ICC Institute of World Business Law, will speak to Iranian participants.

This seminar is directed at business lawyers, corporate counsels and public sector officials, and it will be an excellent opportunity for practitioners to benefit from the experience of the speakers.
